Normal avian gut flora for chickens and turkeys.

INDICATIONS

Aviguard is a natural, live, intestinal microflora derived from SPF chickens and manufactured by fermentation. The preparation is intended to establish, maintain or to restore a balanced and normal gut flora.

Aviguard is a lyophilised powder soluble in water.

STORAGE

Store in a refrigerator between 2 °C and 8 °C.

WARNINGS

- KEEP OUT OF REACH OF CHILDREN, UNINFORMED PERSONS AND ANIMALS.
- Although this remedy has been tested under a large variety of conditions, failure thereof may ensue as a result of a wide range of reasons. If this is suspected, seek veterinary advice and notify the registration holder.

PRECAUTIONS

- Handle with care.
- Store away from food and feed.
- Do not eat, drink or smoke during or after handling of the product, before hands are thoroughly washed.
- Prevent contamination of food, food utensils, drinking water, grazing, etc.
- Unused product should not be kept for later use. Dispose of empty containers and any unused product according to local waste disposal regulations and do not reuse for any other purpose.

DIRECTIONS FOR USE – USE ONLY AS DIRECTED

Spray application

For day-old chicks and turkey poult immediately after hatch.

Dissolve the entire contents of this packet in 0,5 l to 1,0 l (1,25 l to 2,5 l or 2,5 l to 5 l) of fresh water to obtain a spray volume of 250 ml to 500 ml 000 birds. Dissolve the entire contents of the packet in the appropriate amount of fresh water to obtain a spray volume of 250 ml to 500 ml per 1 000 birds.

The ready-to-use solution is applied as a single spray over day-old birds, using a manual or automatic sprayer device delivering coarse droplets.

Drinking water application

In growing and adult poultry (e.g. following antimicrobial medication).

Dissolve the entire contents of the packet in an amount of water corresponding to the usual water consumption of 4 to 8 hours and give this amount as the only source of drinking water during an appropriate time of day.

Open the packet immediately before preparing the ready-to-use solution.

Opened packets cannot be stored.

Ready-to-use solution must be applied within a short time after dissolving the powder.
Water must be free of chlorine (< 0,1 ppm) and disinfectant contamination; otherwise the viability of the bacteria in the preparation may be impaired.

In order to avoid direct contact with the preparation of live bacteria, wear a mask and gloves when preparing the ready-to-use solution.

PRESENTATION

Packages of 25 g, 62,5 g or 125 g sufficient to treat 2 000, 5 000 or 10 000 birds respectively.
Not all pack sizes may be marketed.

Normale voëldermflora vir hoenders en kalkoene.

INDIKASIES

Aviguard bevat natuurlike, lewende intestinale mikroflora wat afkomstig is van SPV hoenders en wat deur fermentasie vervaardig is. Hierdie produk word gebruik om 'n normale, gebalanseerde dermflora te behou en te herstel. **Aviguard** is 'n gevriesdroogde wateroplosbare poeier.

BERGING

Berg in 'n yskas tussen 2 °C en 8 °C.

WAARSKUWINGS

- HOU BUITE BEREIK VAN KINDERS, ONINGELIGTE PERSONE EN DIERE.
- Alhoewel hierdie middel breedvoerig onder 'n wye verskeidenheid toestande getoets is, mag dit faal as gevolg van verskeie redes. Indien dit vermoed word, raadpleeg 'n veearts en verwittig die registrasiehouer.

VOORSORGMAATREëLS

- Hanteer versigtig.
- Bêre weg van voedsel en voer.
- Moenie eet, drink of rook tydens, of ná hantering van hierdie produk, voordat hande nie deeglik gewas is nie.
- Voorkom kontaminasie van kos, eetgerei, drinkwater, weiding, ens.

GEBRUIKSAANWYSINGS – GEBRUIK SLEGS SOOS AANGEDUI

Sproeitoediening

Vir dag-oue kuikens en kalkoentjies onmiddellik na uitbroei.

Los die hele inhoud van die pakkie op in 'n geskikte hoeveelheid vars water om 'n sproeivolume van 250 tot 500 ml per 1 000 voëls te verkry, bv.:

- 25 g pakkie (2 000 dosisse) in 0,5 tot 1,0 l vars water,
- 62,5 g pakkie (5 000 dosisse) in 1,25 tot 2,5 l vars water en
- 125 g pakkie (10 000 dosisse) in 2,5 tot 5,0 l vars water.

Die gereed-vir-gebruik oplossing word as 'n enkeltoediening, met 'n hand- of outomatiese sproeier wat growwe druppels lewer, aangewend.

Drinkwatertoediening

In groeiende en volwasse pluimvee (bv. na antimikrobiële medikasie).

Los die inhoud van die pakkie op in 'n hoeveelheid water wat ooreenstem met die hoeveelheid water wat gewoonlik binne 'n periode van 4 tot 8 ure deur die voëls verbruik word. Gee die oplossing dan as die enigste waterbron gedurende hierdie periode. Toediening kan op enige geskikte tyd van die dag toegedien word.

Maak die pakkie oop net voor die gereed-vir-gebruik oplossing aangemaak word.
Oop pakkies kan nie geberg word nie.
Gereed-vir-gebruik oplossings moet onmiddellik gebruik word.
Water moet vry van chloorverbindings (< 0,1 dpm) en ontsmettingsmiddels wees, anders kan die bakterieë se lewensvatbaarheid benadeel word.
Vermy direkte kontak met die lewendie bakterieë deur handskoene en 'n masker te dra terwyl die wateroplossings aangemaak word.

AANBIEDING

Pakkies van 25 g, 62,5 g of 125 g genoeg vir onderskeidelik 2 000, 5 000 of 10 000 voëls.
Nie alle verpakkingsgroottes word noodwendig bemark nie.
